## TERMS & CONDITIONS

This Sponsorship Agreement (the “Agreement”) is entered into between \_\_\_\_\_ (Company), a \_\_\_\_\_ (Company Type) (“Sponsor”) and the Utah Cybersecurity Society (“UCS”), a nonprofit corporation, as of \_\_\_\_\_, 20\_\_\_\_ (“Effective Date”).

**SPONSORSHIP RIGHTS.** UCS grants to Sponsor a Sponsorship for the BSidesRedRocks Conference for 2025 (the “Conference”).

**SPONSORSHIP BENEFITS.** UCS agrees, subject to the provisions in this Agreement, to provide to the Sponsor the benefits described in Exhibit A attached hereto and made part thereof.

**FEE.** In the consideration of the grant by UCS to the Sponsor of the Sponsorship rights hereunder, the Sponsor agrees to pay the sponsorship fee no later than ten (10) days following the latter to occur of the mutual execution of this Agreement and the Sponsor’s receipt of an invoice.

**TERM.** This Agreement shall begin on the Effective Date and shall continue through the conclusion of the scheduled Event.

**CANCELLATION BY SPONSOR.** The sponsor may elect to cancel the sponsorship. After September 14, 2025, all payments made to UCS or agreed to under this Agreement shall be deemed fully earned and non- refundable in consideration for expenses incurred by UCS and UCS’s lost or deferred opportunity to provide sponsorship opportunities to others. Cancellation notices must be in writing and sent to [sponsors@bsidesslc.org](mailto:sponsors@bsidesslc.org).

**OBSERVANCE OF LAWS AND RULES:** Sponsor agrees to observe and abide by all laws, rules and regulations, and ordinances in connection with this Agreement and the rules of any Event to which Sponsor may be invited to participate from time to time as a result of being a Sponsor.

**LICENSE.** Sponsor grants to UCS the non-exclusive, non-transferable right to use trademarks, trade names, service marks or logos owned by it (“Sponsor Marks”) in connection with the Event(s) and any activities or promotions reasonably incidental thereto. UCS hereby renounces ownership of and assigns to Sponsor any goodwill that accrues as the result of the use of Sponsor Marks.

**REPRESENTATIONS AND WARRANTIES.** Sponsor represents and warrants to UCS that: (i) Sponsor has the full right, power and authority to enter into this Agreement; and (ii) the distribution or use of any products or materials provided by Sponsor will not violate the rights of any third party including, without limitation, copyrights, trademarks, patents, and other intellectual property rights of any third party. UCS represents and warrants to Sponsor that: (i) UCS has the full right, power and authority to enter into this Agreement; and (ii) the use of any materials prepared by UCS (other than by

way of incorporation of any Sponsor provided materials) will not violate the rights of any third party including, without limitation, copyrights, trademarks, patents, and other intellectual property rights of any third party.

INDEMNIFICATION. Neither UCS, any co-sponsor, venue provider nor any of their respective officers, agents, employees, contractors, facilities, representatives or assigns shall be liable for, and Sponsor hereby releases them from, any claims for damage, loss, expense, harm, or injury or death to the person, property or business of the Sponsor and/or any of its visitors, officers, agents, employees, contractors, or other representatives, resulting from theft, fire, earthquake, water, unavailability of the facility, uncontrollable events, third parties, accident or any other reason in connection with any Event. The Sponsor hereby indemnifies, and shall defend, and protect UCS and hold UCS, any co-sponsor and venue provider harmless from any and all claims, demands, suits, liability, damages, losses, costs, attorney's fees, and expenses which might result or arise from Sponsor's participation at an Event or any actions of the Sponsor's officers, agents, employees, contractors, or other representatives.

LIMITATION OF LIABILITY. IN NO EVENT SHALL EITHER PARTY OR ITS RESPECTIVE AFFILIATES BE LIABLE FOR ANY CONSEQUENTIAL, PUNITIVE, INDIRECT, INCIDENTAL, RELIANCE, OR SPECIAL DAMAGES, WHETHER OR NOT SUCH PARTY HAS BEEN ADVISED OF THE POSSIBILITY THEREOF. IN NO EVENT SHALL UCS'S LIABILITY, UNDER ANY CIRCUMSTANCE, EXCEED THE AMOUNT ACTUALLY PAID TO IT BY THE SPONSOR. UCS MAKES NO REPRESENTATION OR WARRANTY REGARDING THE NUMBER OR IDENTITY OF PERSONS WHO WILL ATTEND ANY EVENT.

MODIFICATIONS. Any waiver, discharge, amendment or other modification of any provision of this Agreement will be valid and effective only if it is evidenced by a writing signed by both parties to this Agreement.

NO JOINT VENTURE. This Agreement does not constitute and shall not be construed as constituting a partnership or joint venture between Sponsor and UCS. Neither party shall have any right to obligate or bind the other party in any manner whatsoever except as provided herein.

ASSIGNMENT. Neither party may assign this Agreement without the prior written consent of the other party. Notwithstanding the foregoing, either party may assign its rights and/or duties under this Agreement to any affiliate or successor entity in connection with a merger, reorganization or other corporate restructuring.

GOVERNING LAW. This Agreement shall be construed and interpreted pursuant to the laws of the State of Utah without regard to its conflict of law principles.

SURVIVAL. Anything to the contrary notwithstanding, the representations, warranties and indemnities provided for in this Agreement shall survive the execution and performance and any termination or expiration of this Agreement.
